Located in nearly 40 communities, Youth Volunteer Corps (YVC) recruits teams of diverse youth between the ages of 11 and 18 to perform service learning projects in their communities. The projects address unmet needs of the community while promoting a lifetime ethic of service among young people. In the 2018-19 program year, 6,357 youth completed 123,526 volunteer hours. These contributions of service were addressing needs in homeless shelters, food banks, local parks, children's literacy programs, assisted living for senior citizens, pet adoption agencies, and many others. Youth completed 4,112 different projects, which had an impact on tens of thousands of people and animals who benefit from the agencies helped by our youth volunteers.
