Located in nearly 40 communities, Youth Volunteer Corps (YVC) recruits teams of diverse youth ages 11-18 to perform service learning projects in their communities. The projects address unmet needs of the community while promoting a lifetime ethic of service among youth people. In the 2020-21 program year, 3,604 youth completed 60,015 volunteer hours. These contributions of service were addressing needs in homeless shelters, food banks, local parks, children's literacy programs, assisted living for senior citizens, pet adoption agencies, and many others. Youth completed 3,012 different projects, which had an impact on tens of thousands of people and animals who benefit from the agencies helped by our youth volunteers.
